# **Target Market Summary**

This product is intended for use as a standalone to satellite allocation for a consumer who is seeking income and some capital growth from a diversified defensive portfolio of growth and income generating assets and has a *low to medium* risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 2 years or more, and who needs to withdraw their money on less than one week's notice.

# **Description of Target Market**

#### Appropriateness
