

Betashares Cloud Computing ETF: PDS Update

Nature of update:

The index methodology for the Indxx Global Cloud Computing Index ("Index"), which the Fund aims to track before fees and expenses, has been updated by Indxx, LLC, the index provider, to broaden the scope of the "Software as a Service (SaaS)" and "Infrastructure as a Service (IaaS)" themes for index security selection purposes. This change will be reflected in the Index as at the next rebalance in May 2025.

To reflect this update, the Fund's PDS is updated in section 2.1.3 "About the Index" on page 7 by deleting and replacing the "Software as a Service (SaaS)" and "Infrastructure as a Service (IaaS)" rows in the first table of this section with the following:

Software as a Service (SaaS)	Companies that are involved in licensing and delivery of software over the internet on a subscription basis which is sometimes called "on-demand software". Terms such as "recurring revenues", "annualised recurring revenues", or "subscription revenues" are also included for a broader range of subscription software- based cloud computing services.
Infrastructure as a Service (IaaS)	Companies that are involved in providing virtualised computing resources over the internet. The services include shared resources like shared storage, shared servers, storage pool etc. The subtheme also includes Database-as-a-service

	companies or companies providing cloud-based solutions for data management on a subscription basis.

The other themes detailed in the first table of section 2.1.3, being "Platform as a Service (SaaS)", "Data Centre REITs" and "Cloud and Edge Computing Infrastructure / Cloud Infrastructure Components", are not affected by this update and remain unchanged.
