QETH obtains its exposure to physically-settled Ethereum by investing in the NYSE-listed Bitwise Ethereum ETF run by the largest crypto index fund manager in the US, Bitwise. The underlying Ethereum assets are held by a leading global digital asset custodian.

Regulation and professional custody

Unlike cryptocurrency trading platforms, which can be subject to varying levels of regulation, QETH is subject to the same regulation as all ASX-traded ETFs. The underlying holdings of Ethereum are primarily held offline in cold storage by a leading global digital asset custodian.



Transparent valuation and holdings

QETH's net asset value (NAV) is published daily on the Betashares website along with the amount of Ethereum held per unit.

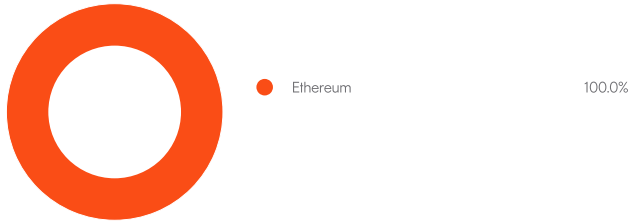
