***On 1 September 2024 Bendigo Superannuation changed ownership from Bendigo and Adelaide Bank to the Betashares Group.***

***Remuneration expenditure*** includes the remuneration of the Trustee's key management personnel (KMP) for the year ended 30 June 2024. The Trustee was a wholly owned subsidiary of Bendigo and Adelaide Bank Limited (the 'Bank') during the 2023/24 financial year. The remuneration received by any executive KMP was paid directly by the Bank and the remuneration received by any non-executive KMP was paid by the Trustee. No such amounts are deducted from the Fund. Further information is available in the Remuneration Report, which is included in the Annual Financial Report.

***Political donations*** – the Trustee does not make political donations.

***Promotion, marketing and sponsorship expenditure*** includes promotional, distribution and media costs to grow the Fund.

***Industrial body payments*** – the Trustee does not make payments to industrial bodies as defined under Fair Work (Registered Organisations) Act 2009.

***Related party payments*** – the Trustee does not make payments to related entities for services provided to the Trustee and Fund. The Bank paid the remuneration of staff and executive officers, and certain expenses for business operations of the Trustee and the Fund. The Bank did not seek reimbursement from the Trustee and Fund for amounts paid.
